7- If I were running the training I would:

I would have the whole Wednesday section outside. What about chairs under a tree for some of the talks -that occurred in AM.

Mix field classroom more.

Have it again in 3 years

Have agents plant tomatoes in bags

Provide at least one social activity for participants ex: schedule social time couple hours etc.

Offer all power points via the web. Have web access for presenters to use during training. My office has a wireless hub that gets that done.

Have a 2 hour field session in the morning the second day, and another 2 hour session in the afternoon rather than 4 hours at a time to help break up the powerpoint and classroom time more.

Overall, though, it was a great training.

Be sure map is right

Split the longer time blocks given to 1 speaker into multiple speakers or rotate speakers. Ex: 2 hours of powerpoint by 1 speaker in TOO long, Mix it up!

Provide internet access for presenters or let them know that she will not have any and can make different arrangements for her presentation.

One morning have sausage biscuits. 2 full days instead of 3.
